Minutes of the Meeting held at 7.30 p.m. on Thursday 25th May 2017 in the Town Hall, Huntingdon

# 1. Apologies for Absence:

# 2. Minutes of the last Meeting:

The Minutes of the 2016 AGM were signed as correct by the Chairman, Philip Saunders.

# 4. Membership Secretary's Report

Jean Burbidge reported that the Society has 204 Facebook and email contacts – and this is a very positive way of keeping the Society in touch with its members. She awarded stars: Kate Hadley for being the Society member who has encouraged the greatest number of visitors to become members. Rosemary & David Smith for being so welcoming and friendly to everyone. Beryl Durant for helping with refreshments after the lectures. Jean recommended the May Weekend to everyone as being good value, very sociable and full of interest.

#### 5. Excursions Report

Philip Saunders read a note, sent by David Cozens in his absence, which reported on the successful and very enjoyable summer excursions. Overall these were well supported and had financially broken even

#### 6. Treasurer's Report

David Smith presented his report, and full copies of the audited Annual accounts were made available to members. His presentation – with pie charts and colourful graphs - demonstrated the continuing sound financial position of the Society. The Society's assets had risen by c £10,000 over the year due to the strong FTSE. There were no questions to the accounts, David was thanked for his work over the year.

#### 7. The Goodliff Bequest

Kate Hadley reported that there were 14 applications from which there were 13 Awards. The total amount granted was £6,360.00 of a recommended 'ceiling' of £7,000. Philip explained that this sum was reviewed each year on the advice of the

Society's Treasurer. We had also deliberately held back from allocating all £7,000 mindful that the society expected to support publication of an enhanced edition of Richard Hewlings' *History of Huntingdon Town Hall* in 2018.

The successful applicants were:

**Dr Charles Beresford:** A book to illustrate and describe the angel roof and medieval carvings and angels and painted roof of Hemingford Abbots Church.

**Jane Brown:** A book about the history of All Saints Church, Elton as a mirror of life in the village c.900 to c.2000.

**St Neots Museum:** Funding for six information panels to tell the story of the local Iron Age hoard - the Kimbolton Coin Hoard. (The hoard was purchased by St Neots Museum with help from the Goodliff Fund.)

Herbert Goodwin: To bind volumes of transcripts of documents relating to St Neots, Great Paxton and Toseland, and personal reminiscences of the parishes. Ramsey Rural Museum: For purchase of film from East Anglia Film Archive. (Last year's Goodliff Award provided audio visual equipment for display areas throughout the museum.) The EAFA films will show farming through the seasons, how the Fens were drained, and a selection of rural trades. The film will enhance the visitor experience.

**St Neots Community Archive Group:** Funding for one Poppy Plaque and Poppy Trail in St Neots. It is proposed to place a sculptured poppy plaque by each of the 25 St Neots war graves (both WW1 and WW2) and publish a leaflet Poppy Trail around the town to show where the Commonwealth War Graves are.

**Jonathan Latter:** Support for an illustrated book about local and national events mirrored in the history of St Thomas a Becket Church, Ramsey.

**Karen Pauley:** Financial help to produce a book as part of the 'Godmanchester Remembers the Somme' Poppy Project, updated this year with Passchendaele. This community project researched 14 Godmanchester men who lost their lives at the Battle of the Somme.

**Huntingdon Town Council**: Contribution towards development of Huntingdon Heritage Centre project. The proposal is for production of a programme of exhibitions in the Town Hall and across the town of Huntingdon over a 3-5 year period. Huntingdon Town Council will apply for a Heritage Lottery Grant, which would allow the appointment of a Heritage Officer.

**The Norris Museum, St Ives:** For purchase of specialist racking for storage of farming equipment.

**Ermine Street Church Academy:** For a project for this new school to capture and the history of the foundation of this new school and the surrounding new development at Alconbury Weald.

**Dr Ken Sneath**: Financial help towards production of a scholarly monograph on The Consumer Revolution' based upon Huntingdonshire.

**Friends of Ramsey Mortuary Chapels:** Assistance with the purchase of a roller banner, interpretation boards and leaflets.

Simon Thurley, the Society's President, will present the Awards at the October meeting.

Applications for awards for 2018 are invited by 31<sup>st</sup> March 2018.
